

NAPLAN privacy notice

Notice of collection under Australian Privacy Principle 5 (Privacy Act 1988 Cth)

Personal information about your child and you (parents/guardians) will be collected for the National Assessment Program – Literacy and Numeracy (**NAPLAN**) tests.

The Australian Curriculum, Assessment and Reporting Authority (**ACARA**) conducts the NAPLAN tests and creates national reports on schooling, including reporting on the [My School](http://www.myschool.edu.au) website.

State and territory education authorities are responsible for running NAPLAN tests, including managing student data and reporting results to schools and students.

Section 40 of the *Australian Curriculum, Assessment and Reporting Authority Act 2008* (Cth) authorises ACARA to collect personal information for purposes including producing national reports and informing education policy. ACARA protects the data it collects in line with the standards in the *Privacy Act 1988* (Cth) and only collects data that is anonymised (that is not linked to student names). NAPLAN Online

Education Services Australia Limited (ESA) operates the NAPLAN Online system. [ESA](http://esa.edu.au) (esa.edu.au) is a national, not-for-profit company owned by all Australian education ministers. ESA collects, stores, uses and discloses student personal information on behalf of state and territory education authorities and ACARA for purposes related to NAPLAN. Data stored may include assessments and data archived for inclusion in a future Longitudinal Data Store. Collection

A state or territory education authority will collect personal information about your child and you in relation to the online or paper NAPLAN test. State and territory education authorities also collect student names and other information for student and school level reporting and related purposes.

The state or territory education authority will make anonymised information available to ACARA. ACARA will also collect anonymised information about students who take the test online from the student and their school.

ACARA will collect the following categories of information for each student (noting that for some categories there will be multiple data fields): student identifier, sex, date of birth, country of birth, language background, whether your child identifies as an Aboriginal or Torres Strait Islander, parent occupation and parent education, as well as participation and performance information (e.g. multiple choice and written responses).

Disclosure

ACARA will not disclose personal information about your child and you unless it is authorised by law and will not disclose personal information overseas. More detailed information is contained in ACARA's [privacy policy](http://acara.edu.au/contact-us/privacy) at acara.edu.au/contact-us/privacy.

Access and correction

ACARA is **not** able to match information it receives or collects with individual students. If you wish to access or correct your child's personal information or NAPLAN data, contact your child's school in the first instance. Complaints
